

ORDINANCE NO. 2022 - 012

AN ORDINANCE AUTHORIZING A COLLECTIVE BARGAINING AGREEMENT BETWEEN THE CITY OF KENT AND THE CIVILIAN EMPLOYEE UNIT, FRATERNAL ORDER OF POLICE, OHIO LABOR COUNCIL FOR THE PERIOD OF NOVEMBER 1, 2021 THROUGH OCTOBER 31, 2024, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Kent, Ohio and the Civilian Employee Unit, Fraternal Order of Police, Ohio Labor Council, have agreed to the terms of a labor agreement to be effective from November 1, 2021 through October 31, 2024; and

WHEREAS, it is in the best interests of the employees and the City of Kent to adopt this ordinance as soon as possible.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio, at that:

**SECTION 1.** the Administration is hereby authorized to enter into a collective bargaining agreement in the form and upon the terms set forth in the tentative agreement between the City and the Civilian Employee Unit, Fraternal Order of Police, Ohio Labor Council, for the period of November 1, 2021 through October 31, 2024, as is fully set forth in Exhibit "A", on file with the Clerk of Council.

**SECTION 2.** it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 3.** this ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of this City, for which reason and other reasons manifest to this Council this ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediate after passage.
