ORDINANCE NO. 2022- 039

AN ORDINANCE AUTHORIZING THE CITY MANAGER, OR HIS DESIGNEE TO DISPOSE OF THE POLICE DEPARTMENT'S OLD MOBILE DATA TERMINALS ON THE BASIS THAT THEY ARE NOT COMPATIBLE WITH THE OPERATING SYSTEM, ARE NOT NEEDED FOR MUNICIPAL PURPOSES, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Kent would like to dispose of 13 Panasonic Toughbook CF31 computers that were used as in-car computers; and

WHEREAS, these computers have been stored with no anticipation of future use and are not compatible with the operating system. The mobile date terminal are no longer needed for municipal purposes.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kent, Portage County, Ohio, that:

<u>SECTION 1.</u> Council does hereby authorize the City Manager, or his designee, to dispose of 13 Panasonic Toughbook CF31 computers that were used as in-car computers and are no longer compatible with the operating system.

<u>SECTION 2</u>. it is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

SECTION 3. this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
