

ORDINANCE NO. 2022 - 074

**AN ORDINANCE AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO ACCEPT GRANT FUNDING FOR THE KENT HEALTH DEPARTMENT NOT TO EXCEED \$171,000 FOR SPECIFIC PROGRAMS, AND DECLARING AN EMERGENCY**

**WHEREAS**, the City of Kent Health Department has actively pursuing grants that will either bring in funds or other resources for specific programs. All monies rewarded will not exceed \$171,000; and

**WHEREAS**, below is a list of grants the money will be used for:

- EPA Grant for Vector Control - \$25,000 (money has been awarded)
- Tobacco Use 2023 (TU23) - \$132,000 (money has been awarded)
- Healthy Eating & Active Living (HEAL) - \$10,000 (money has been awarded)
- Community Health Worker (CHW) – will receive a paid worker from AxcessePointe (not awarded yet)
- Staying Active and Independent Living (SAIL) – not to exceed \$4,000 (not awarded yet)

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Kent, Portage County:

**SECTION 1.** That Kent City Council hereby authorizes the City Manager, or his designee, to accept the grant funding not to exceed \$171,000 to be used by the Kent Health Department for the programs listed above.

**SECTION 2.** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and of any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 3.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Ordinance is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
