

RESOLUTION NO. 2021-054

A RESOLUTION APPOINTING THOMAS PASCARELLA, KATHIE SLATER, AND BENJAMIN TIPTON TO THE SALARY REVIEW COMMITTEE, AND APPOINTING WARNER MENDENHALL AND JEFF ROEGER AS ALTERNATES, AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Kent, Portage County, Ohio, at least a majority of all members elected thereto concurring:

SECTION 1. That THOMAS PASCARELLA, KATHIE SLATER, AND BENJAMIN TIPTON and alternates WARNER MENDENHALL AND JEFF ROEGER are hereby appointed to the SALARY REVIEW COMMITTEE.

That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the residents of this City, for which reason and other reasons manifest to this Council this Resolution is hereby declared to be an emergency measure and shall take effect and be in force immediately after passage.
